I. Applicant Information

Section I information applies to the person submitting the application for membership. Applicants are required to list one contact person. Multiple names are not allowed in the first name and last name fields. Authorized agents are persons authorized to sign and conduct business through this membership. Junior members are required to have an authorized agent, such as a parent or guardian on their member account. Junior applicants must include their birthdate to determine their junior status. Junior members are not allowed to have a ranch name. Once a membership has been established, they are never deleted, only made inactive. This ensures accuracy in not setting up a duplicate membership. If you have had an ABGA goat registered in your name, but you are not a member, then you would have a non-member account already set up. Upon receipt of your membership application, we can make the non-member account an active membership account. First name, last name, address, city, state, zip, county of residence, home phone, birth date, and authorized agent are required fields. In order to receive information via email, you must complete the email field.

ABGA Online Web Based Service - Provides ABGA members with opportunities to research, in detail, more than 300,000 American Boer Goats. ABGA Online is the World's largest online database for Purebred Boer Goats. To sign up for ABGA Online Web Base Service, please check the box for ABGA Online Web Base Service. The user information and password will be e-mailed to you after processing. ABGA Online Live is a member service which allows members to register, transfer, receive temporary certificates, manage herd inventories, and pay for services online. Each new member is sent an email invitation to create their own unique password.

ll. Herd Prefix:

It is required that a breeder and/or member have an ABGA herd prefix. The herd prefix is 3 to 5 numbers or letters (no special characters or spaces are allowed). See ABGA Rules and Regulations. Each membership is limited to one herd prefix, and once approved, the herd prefix cannot be changed. ABGA requests three selections because the prefixes cannot be duplicated. Once reserved the herd prefix is permanently maintained by the Association regardless of the members' status. A herd prefix may be transferred to another breeder only upon written request of the owner, heirs, or assigns. Members of the same household may share the same herd prefix.
