### **ABGA National Show**

**JABGA High Point Series Poppers**- T.D. Wall has agreed to sponsor four poppers for the High Point Overall winners. TD wall is requesting that all winners of the poppers sign an agreement that they will maintain ownership of the box for a minimum of one year and leave all branding stickers on the box. If the recipients wish to sell after one year, they must offer T.D Wall first purchase rights.

# Kim Veal makes the motion to approve the contract requirement as requested by T.D. Wall for the winners of the Overall High Point Poppers. Seconded by Casey McClain. Voice vote. Motion passed.

**2025 JABGA National Show Theme-**The JABGA requested that their theme for 2025 ABGA National Show is Tropical.

**National Invitational Sale (30+Lots)-**The sale is being organized by Drew Williams and Herdbuilder. - Drug Testing Protocol policy reviewed- how random sample will be chosen, and medication reports. All
  exhibitors will place all medication reports in a lockbox that is only unlocked by 3<sup>rd</sup> party handling the drug

testing. The exhibitor signs the cover form stating that they personally placed all required forms into the lockbox. **Drug testing policy and forms are tabled until the May ABGA meeting.** 

• Food and Snacks for Tables-Brad Mackey will help sponsor the funding of the snack items for the ringside tables.
